DIRECTIONS

From Philadelphia (Walt Whitman Bridge) Follow 42 S. to I-295 N. Take I-295 N. and exit at 40A (Rt. 38). Stay on Rt. 38 east for approx. 2.7 miles. Turn right onto jug handle for Fostertown Rd. and cross Rt. 38. The Igloo is 1/4 mile on the right hand side.

From North Jersey Follow all routes to I-295 S. Exit at 40A (Rt. 38). Stay in the right hand lane and look for the jug handle that will allow you to turn around and travel east on Rt. 38. Take Rt. 38 east for approx. 3 miles. Turn right onto jug handle for Fostertown Rd. and cross Rt. 38. The Igloo is 1/4 mile on the right hand side.
