



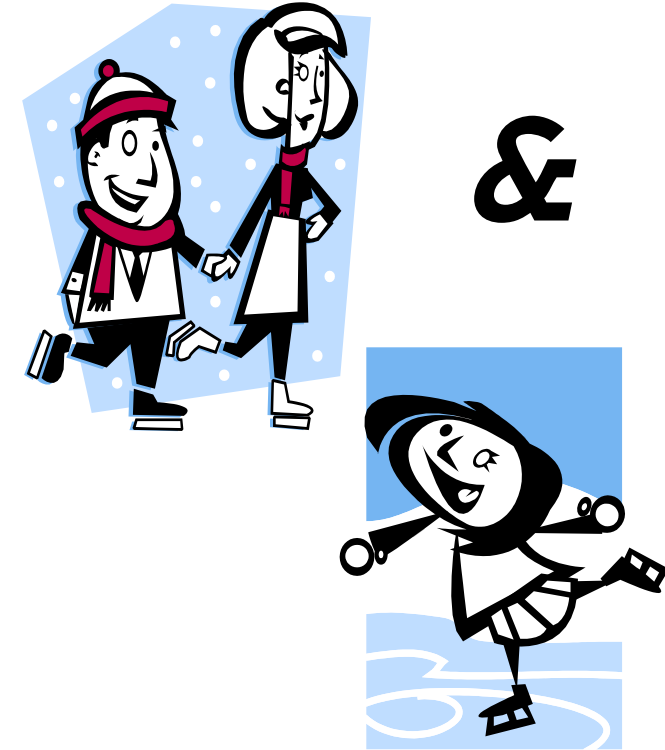

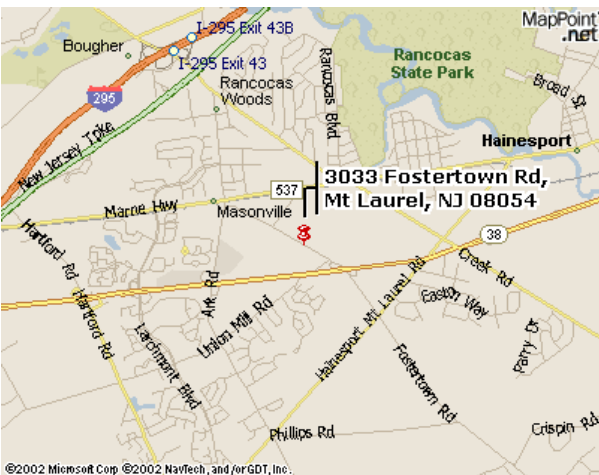

# Parent & Tot Session 1

The IGL00 at Mt Laurel offers group skating lessons from ages 3 to adult, all under the tutelage of **Professional Staff Coaches**. Each skater is registered with USFSA and will receive a log book and badges for all completed levels. The classes are designed to take skaters from beginning through advanced levels.

### What to bring and wear:

Participants should arrive 20 minutes prior to start time. Gloves are a necessity. Dress in layers with warm comfortable clothing.

**WE REQUIRE ALL CHILDREN 6 AND YOUNGER WEAR A HELMET. ALL SKATERS WEARING HOCKEY SKATES MUST WEAR A HELMET WITH MASK.**

### Policies:

**NO MAKE-UP CLASSES AND NO REFUNDS** once a class has started.

**Pro Rated policy:** classes will be pro rated once a class session has started only!

Tuition must be paid in advance to secure a position in class. We recommend participants register at least 7 days in advance of the start of your program.

### Program Costs only \$125.00

- Includes 6 weekly classes (includes skate rental).
- USFSA membership included in fee.
- Participants with full prepaid packages receive a pass good for 5 public skating sessions (does not include skate rental).
- Class 1/2 hr. Practice 1/2 hr.

Parent participation is not required, but presence is **REQUIRED!**



**Snow Plow Sam 1/2/3:** (ages 3-6) Introduction to skating, development of coordination and necessary skills to advance to basic skating classes.

**Snow Plow Sam 1:** Introduces students to marching in place, moving forward, gliding and bending the knees.

**Snow Plow Sam 2:** Builds on Slow Plow Sam 1, adding backward swizzles, rocking horses and gliding.

**Snow Plow Sam 3:** Builds on Snow Plow Sam 2, adding more advanced swizzles, stopping, curves and one foot glides. This is also the bridge to Basic 1-8 classes.
